INDICTMENT

The Grand Jury charges:

Count One

Murder-for-Hire

(Violation of 18 U.S.C. § 1958)

On or about April 3, 2012, in the Fort Worth Division of the Northern District of Texas, defendant **Ryan Walker Grant** used and caused another to use a facility of interstate commerce, specifically a cellular telephone, and intended to cause another to travel in interstate and foreign commerce, with the intent that a murder be committed in violation of the laws of Texas, as consideration for the receipt of, and as consideration for a promise and agreement to pay, something of pecuniary value, namely a sum of money.

In violation of 18 U.S.C. § 1958.

Count Two
Unlawful Transfer of a Firearm
(Violation of 18 U.S.C. § 922(d)(1))


On or about November 8, 2011, in the Fort Worth Division of the Northern District of Texas, defendant **Ryan Walker Grant** knowingly transferred a firearm, that is, a Norinco, Model SKS, 7.62x39mm semi-automatic rifle, serial number 1218114, knowing and having reasonable cause to believe that the recipient of the firearm had been convicted of a crime punishable by imprisonment for a term exceeding one year.

In violation of 18 U.S.C. § 922(d)(1), the penalty for which is found at 18 U.S.C. § 924(a)(2).




