

COMPLAINT

COMES NOW International Driver Training, Inc. ("Plaintiff") and herewith sets forth its Complaint against Steven Andrew Schlosser d/b/a 3D Defensive Driving ("3D" and/or "Defendant") as follows:

JURISDICTION

- 1. This is an action for trademark infringement and unfair competition arising under the Trademark Act of 1946, as amended, 15 U.S.C. § 1051 *et seq.*; trademark infringement and unfair competition under Texas common law; and trademark infringement and dilution under the Texas Business and Commerce Code ("Tx. Bus. & Com. Code").
- 2. This Court has jurisdiction over all causes of action set forth herein pursuant to 15 U.S.C. § 1121, 28 U.S.C. §§ 1331, 1338(a) and 1338(b), and the supplemental jurisdiction of this Court as provided in 28 U.S.C. § 1367.
- 3. Venue is proper in this judicial district and division pursuant to 28 U.S.C. § 1391(b), and §1391(c).

4. This Court has personal jurisdiction over Defendant insofar as Defendant is a resident of the State of Texas, and Defendant committed the acts referenced in this Complaint within the State of Texas and within this judicial district and division.

THE PARTIES

- 5. Plaintiff is a Texas corporation with its principal place of business at 8200 Springwood Dr. #250, Irving, Texas 75063.
- 6. Defendant is an individual resident of the State of Texas, doing business under the assumed name 3D Defensive Driving. Defendant has an address of 3714 Rocky Woods Drive, Kingwood, Texas 77339.

RELEVANT FACTS

- 7. Plaintiff commenced its business operations in 1989. Since 1989, Plaintiff has been providing live classroom and online educational services, namely, conducting state approved driver safety courses taught by local and nationally recognized comedians. As of June 2012, Plaintiff has provided services to over three million (3,000,000) students throughout the state of Texas.
- 8. Since at least as early as 1990, Plaintiff has used the marks "COMEDY DEFENSIVE DRIVING SCHOOL" ("Mark 1") and "COMEDY DEFENSIVE DRIVING" ("Mark 2") in association with its educational services, namely its defensive driving courses (collectively, Mark 1 and Mark 2 are hereinafter referred to as "Marks 1-2").
- 9. Since at least as early as 1993, Marks 1-2 have been used in interstate commerce in various capacities to promote Plaintiff's educational services by, without limitation, displaying the Marks on Plaintiff's Internet web site; and distributing coupons and advertisements

displaying the Marks. True and correct examples of Plaintiff's broad use of Marks 1-2 in association with its educational services are attached hereto as Exhibit A.

- 10. Since at least as early as 2009, Plaintiff has used the mark "COMEDY DRIVING SCHOOL" ("Mark 3") in association with its educational services, namely its defensive driving courses (collectively, Mark 1, Mark 2, and Mark 3 are hereinafter referred to as the "Marks").
- 11. Since at least as early as 2009, Mark 3 has been used in interstate commerce in various capacities to promote Plaintiff's educational services by, without limitation, displaying Mark 3 on Plaintiff's Internet web site; and distributing coupons and advertisements displaying Mark 3. True and correct examples of Plaintiff's broad use of Mark 3 in association with its educational services are attached hereto as Exhibit B.
- 12. Plaintiff is the owner of U.S. Service Mark Registration Nos. 1,798,916 (standard word mark) and 1,798,917 (stylized word mark) for Mark 1, both of which were registered on October 12, 1993 for "educational services, namely, conducting state approved driver safety courses taught by local and nationally recognized comedians" (the "Mark 1 Registrations"). The Mark 1 Registrations are registered on the Principal Register and are valid and incontestable. True and correct extracts from the U.S. Trademark Office's TARR server summarizing the details of Plaintiff's Mark 1 Registrations are attached hereto as Exhibits C-E.
- 13. Plaintiff is the owner of Texas Service Mark Registration No. 051427 for Mark 1, which was registered on December 11, 1991 in association with education and entertainment services in Class 41 (the "Texas Registration"). A true and correct copy of the Certificate of Registration for the Texas Registration, as well as a true and correct extract from the Texas Secretary of State trademark database summarizing the details of Plaintiff's Texas Registration, are attached hereto as Exhibit F.

- 14. Plaintiff is the owner of U.S. Service Mark Registration No. 3,727,846 for Mark 2, which was registered on December 22, 2009 for "educational services, namely, conducting state approved driver safety courses taught by local and nationally recognized comedians" (the "Mark 2 Registration"). The Mark 2 Registration is registered on the Principal Register and is valid and subsisting. A true and correct extract from the U.S. Trademark Office's TARR server summarizing the details of Plaintiff's Mark 2 Registration is attached hereto as Exhibit G.
- 15. Plaintiff is the owner of U.S. Service Mark Registration No. 3,997,184 for Mark 3, which was registered on July 19, 2011 for "educational services, namely conducting driver safety courses, defensive driving courses, traffic school courses and driver education taught by comedians" (the "Mark 3 Registration"). The Mark 3 Registration is registered on the Principal Register and is valid and subsisting. A true and correct extract from the U.S. Trademark Office's TARR server summarizing the details of Plaintiff's Mark 3 Registration is attached hereto as Exhibit H.
- 16. According to <whois.com> (the "Who Is Database"), Defendant owns and operates an online website located at <3ddefensivedriving.com> (the "3D Website"). A true and correct extract from the Whois Database dated July 11, 2012 is attached hereto and incorporated herein as Exhibit I. Defendant provides online driver safety courses to Texas residents via the 3D Website.
- 17. On or about January 10, 2012, well-subsequent to Plaintiff's widespread use of the Marks, Plaintiff became aware that Defendant was using the Marks in association with his online driver safety courses, provided under the company name, 3D Defensive Driving. Several examples of Defendant's unauthorized use of the Marks are set forth in Exhibit J, attached hereto and incorporated herein by reference. Specifically, Exhibit J contains a screen shot from the 3D

Website dated January 10, 2012, the results of a Google® search conducted on January 10, 2012, and an extract from the 3D Website's metadata, dated January 10, 2012.

- 18. On or about January 25, 2012, Plaintiff's counsel sent a letter to Defendant via electronic mail, with confirmation via U.S. Mail, informing Defendant that his unauthorized use of Plaintiff's Marks constituted trademark infringement and unfair competition under federal and Texas state law (the "January Letter"). The January Letter is attached hereto and incorporated herein as Exhibit K. In the January Letter, Plaintiff's counsel demanded that Defendant immediately and permanently cease any and all use of the Marks, and requested a response to its letter by no later than February 1, 2012.
- 19. Subsequent to the January Letter, Plaintiff's counsel and Defendant engaged in a series of correspondences, wherein Defendant refused to cease its use of the Marks in two capacities: (1) In the body of the 3D Website; and (2) In the metadata for the 3D Website.
- 20. As of the date of filing this Complaint, Defendant continues to use and display Plaintiff's Marks, both in the body of the 3D Website and at least seventeen (17) times in the 3D Website's metadata. An example of Defendant's use of Plaintiff's Marks on its website, dated July 11, 2012, is attached hereto and incorporated herein as Exhibit L. A printout of the 3D Website's metadata, dated July 11, 2012 is attached hereto and incorporated herein as Exhibit M.
 - 21. The services offered by Defendant are identical to those offered by Plaintiff.
- 22. The consumers catered to by both Plaintiff's and Defendant's online and classroom driver safety courses are identical.
- 23. Prior to first use of the Marks Defendant, Defendant had constructive notice of Plaintiff's Mark 1 Registrations, Mark 2 Registration, and Mark 3 Registration, pursuant to 15 U.S.C. §1072.

- 24. Since at least as early as January 25, 2012, Defendant has had actual notice of Plaintiff's Mark 1 Registration and Mark 2 Registration. Such actual notice is based on Defendant's acknowledgement of receipt of the January Letter, as well as Defendant's numerous correspondences with Plaintiff's attorney during the period of January 25, 2012 through June, 2012.
- 25. Notwithstanding such constructive and actual notice, Defendant has and continues to prominently use the Marks in association with his driver safety courses and related services, which are marketed under the assumed name, 3D Defensive Driving.
- 26. Defendant's offering of services under the Marks are without the consent, sponsorship or authorization of Plaintiff.
- 27. Due to Defendant's use of the Marks in commerce, members of the purchasing public are likely to be confused as to the source or sponsorship of Defendant's services.
- 28. Defendant's actions were in bad faith and forced Plaintiff to bring this action in this Court to protect its trademark rights in the Marks.

COUNT I FEDERAL TRADEMARK INFRINGEMENT

- 29. Paragraphs 1-28 are realleged and incorporated herein by reference.
- 30. Defendant's unauthorized use of the Marks constitutes a use in commerce of a reproduction, counterfeit, copy, or colorable imitation of Plaintiff's Marks in connection with the sale, offering for sale, and/or advertising of services that are identical to the services provided under Plaintiff's registered trademarks, and that are marketed through the same channels of trade and to the same class of consumers. Such use of the Marks by Defendant is likely to cause confusion, or to cause mistake, or to deceive; and will cause purchasers and potential purchasers

to falsely believe that the goods and services of the Defendant have a sponsorship, approval, status, affiliation or connection with Plaintiff.

- 31. Defendant's use of the Marks is confusingly similar to the Plaintiff's use of its registered Marks, and the unauthorized use of the Marks by Defendant has caused, is causing, and will continue to cause damage and other irreparable injury to Plaintiff unless such use is enjoined by this Court, Plaintiff having no adequate remedy at law.
- 32. Upon information and belief, the aforementioned acts of Defendant have been and are being committed with the knowledge that such acts are causing confusion, or are likely to cause confusion, or to cause mistake, or to deceive. Defendant's acts are therefore intentional, willful, and are maliciously calculated to cause confusion, to cause mistake, or to deceive. As such, this is an exceptional case.
- 33. Defendant's use of a mark confusingly similar to Plaintiff's registered Marks, as set forth in U.S. Service Mark Registration Nos. 1,798,916, 1,798,917, 3,727,846, and 3,997,184, is an infringement of Plaintiff's rights in and to its federally registered trademarks in violation of 15 U.S.C. § 1114.
- 34. In accordance with 15 U.S.C. § 1117, Plaintiff is entitled to recover from Defendant: (1) Defendant's profits, (2) any damages sustained by Plaintiff, and (3) the costs of the instant action. Further, based upon the nature of Defendant's violation of Plaintiff's trademark rights, Plaintiff is entitled to reasonable attorney's fees and the trebling of such profits or damages.

COUNT II FEDERAL UNFAIR COMPETITION

- 35. Paragraphs 1-34 are realleged and incorporated herein by reference.
- 36. In marketing its aforementioned services under the Marks, Defendant has affixed, applied, annexed, or used in connection with its services, a false designation of origin, or a false or misleading description or representation of fact, that is likely to cause confusion, to cause mistake, or to deceive others to believe that Defendant's services are sponsored by, approved by, originate with, or are affiliated with Plaintiff. Defendant has caused, with knowledge of such false designation of origin or description or representation, such services to be offered for sale or use in interstate commerce.
- 37. Defendant has willfully promoted in interstate commerce the sale of its services, in a manner so as to designate falsely an origin or an association with Plaintiff, with Plaintiff's registered Marks, and with Plaintiff's services, so as to cause confusion or mistake among purchasers as to the true origin, source, sponsorship, or affiliation of Defendant's services, all to Defendant's profit and to Plaintiff's damage.
- 38. Plaintiff has been irreparably damaged by the use of such false designation and/or representation, and will continue to be irreparably damaged unless Defendant's acts are enjoined by this Court, Plaintiff having no adequate remedy at law.
- 39. Defendant has intentionally traded upon the goodwill established by Plaintiff through Defendant's advertising and sales of identical services under an identical mark, and by marketing its services under this identical mark in interstate commerce.
- 40. Defendant's acts, as set forth above, constitute unfair competition, false designation of origin, and false description in violation of 15 U.S.C. § 1125(a).

41. In accordance with 15 U.S.C. § 1117, Plaintiff is entitled to recover from Defendant: (1) Defendant's profits, (2) any damages sustained by Plaintiff, and (3) the costs of the instant action. Further, based upon the nature of Defendant's violation of Plaintiff's trademark rights, Plaintiff is entitled to reasonable attorney's fees and the trebling of such profits or damages.

COUNT III COMMON LAW TRADEMARK INFRINGEMENT AND UNFAIR COMPETITION

- 42. Paragraphs 1-41 are realleged and incorporated herein by reference.
- 43. As a result of the public's association of the Marks with Plaintiff, Defendant's use of an identical or deceptively similar mark in connection with its services, which are the same as or are substantially the same as the services of Plaintiff, is likely to cause confusion, to cause mistake, and to deceive.
- 44. Upon information and belief, Defendant has offered for sale and has provided his services with full prior knowledge of the Marks, and Defendant's offering of such services was and is for the willful and calculated purpose of trading on the goodwill and business reputation of Plaintiff as embodied in and symbolized by the Marks.
- 45. Upon information and belief, Defendant has developed, promoted, and offered his services in such a manner as to inevitably suggest an association, affiliation, or sponsorship with, or approval by Plaintiff, so as to cause, or likely cause, confusion or mistake among purchasers as to the origin or sponsorship of Defendant's services, all to Defendant's profit and to Plaintiff's damage.
- 46. The aforesaid conduct of Defendant constitutes infringement of Plaintiff's common law rights in and to the Marks, and further constitutes common law unfair competition

with Plaintiff, all of which has irreparably damaged and will continue to irreparably damage Plaintiff, together with its goodwill and reputation, unless Defendant is enjoined and restrained by this Court, Plaintiff having no adequate remedy at law.

COUNT IV

TEXAS TRADEMARK INFRINGEMENT

- 47. Paragraphs 1-46 are realleged and incorporated herein by reference.
- 48. In marketing its aforementioned services under the Marks, Defendant has used, within the state of Texas, and without Plaintiff's consent, a reproduction, counterfeit, copy, or colorable imitation of Mark 1, which is registered under Tex. Bus. & Com. Code §16.01 et seq.
- 49. Defendant has reproduced, copied, and colorably imitated Plaintiff's Mark 1, and applied such reproductions, copies, and colorable imitations to labels, signs, and advertisements in connection with the distribution of services within the state of Texas.
- 50. Plaintiff has been irreparably damaged by such infringement, and will continue to be irreparably damaged unless Defendant's acts are enjoined by this Court, pursuant to Tex. Bus. & Com. Code §16.26.
- 51. Defendant's acts, as set forth above, constitute trademark infringement in violation of Tex. Bus. & Com. Code §16.26.
- 52. In accordance with Tex. Bus. & Com. Code §16.26, Plaintiff is entitled to recover from Defendant, all of Defendant's profits derived from or damages resulting from Defendant's infringement of Tex. Bus. & Com. Code §16.26. Further, based upon the nature of Defendant's violation of Plaintiff's trademark rights, Plaintiff is entitled to reasonable attorney's fees and the trebling of such profits or damages.

PRAYER FOR RELIEF

WHEREFORE, Plaintiff prays for a judgment of the Court as follows:

- 1. That Defendant, and those persons in active concert or participation with Defendant, be preliminarily and permanently enjoined and restrained from offering or providing services, or promoting and/or authorizing the sale or providing of services, under the Marks, or any other designation, trademark or service mark that is likely to cause confusion, mistake, or deception as to the source or sponsorship of Defendant's services or from otherwise infringing Plaintiff's registered trademarks.
- 2. That this Court order Defendant to deliver up for destruction all documents, signs, packages, forms, advertisements, business cards, letterheads, and/or other representations and means for reproducing the same, or any printed or recorded material that makes references to or depicts the Marks or any designation or mark similar to the Marks, and to destroy or remove all other uses of marks similar to Plaintiff's registered Marks.
- 3. That Defendant be directed to file with the Court and serve upon Plaintiff, no later than thirty (30) days after the issuance of an injunction, a report in writing and under oath, setting forth in detail the manner and form in which Defendant has complied with the injunctions of the immediately preceding paragraphs and any other provision of this Court's Order.
 - 4. That an accounting be conducted and judgment be rendered against Defendant for:
- a. all profits received by Defendant from the sale of services under the Marks and any other trademark, service mark or other designation confusingly similar to the Marks;
- b. all damages in an amount proven at trial from, *inter alia*, Defendant's trademark infringement, unfair competition, false designation of origin and false description or

representation of Plaintiff's trademarks, pursuant to 15 U.S.C. § 1051 et seq. and Tex. Bus. & Com. Code §16.01 et seq.; and

- c. any other actual and compensatory damages in an amount not presently known, but to be computed during the pendency of this action.
- 5. That such damages assessed against Defendant be trebled as provided by 15 U.S.C. § 1117 and Tex. Bus. & Com. Code §16.26.
- 6. That Defendant be required to pay to Plaintiff monetary damages to be used for corrective advertising to be conducted by Plaintiff.
- 7. That Plaintiff have and recover its expenses in this suit, including but not limited to its reasonable attorneys' fees and expenses, recoverable not only under 15 U.S.C. § 1117(a), but also under Tex. Bus. & Com. Code §16.26 and Texas common law.
- 8. That Plaintiff have and recover damages for Plaintiff's loss of business and goodwill suffered.
- 9. That Plaintiff have such other and further relief as this Court may deem just and proper.

JURY DEMAND

Plaintiff demands a trial by jury of all issues so triable.






